

Selected Instructions for Completing the Copyright Disclosure Form

The purpose of this Copyright Disclosure is to record what was created and the circumstances under which it was created. This form is not to be used for software inventions. Software inventions should be reported using the IURTC Software Disclosure available <http://iurtc.iu.edu/ft-disclosure-downloads.html>. Accurate information is critical to assessing the copyrighted material. This is a legally important document, which should be prepared carefully.

Item 1. Provide a short and descriptive title. This title may be posted on the IURTC website and may be shared with others to market the copyright work.

Item 2. Select the type of work from the drop down menu provided:

- Literary works (reports and tests)
- Visual art works (pictorial or graphic)
- Performing art works (motion pictures or other audiovisual work)
- Sound recordings (recordings of music)
- Serials and periodicals (periodical, magazine or similar work)
- Mask works (diagrams of integrated circuits)

Item 5. Please provide a brief description of the work. This information will be used for evaluation and for any required compliance reporting.

Item 6. **This information will be necessary for establishing authorship. Maintain an original copy of the work.**

Item 8. List all sponsors whose funds in any amount have been used for any purpose related to the work. For each sponsor, also provide the grant number, principal investigator listed on that grant and an estimate of the relative contribution. The funding agencies may require reporting of copyrighted works made with their funds. This information is needed by IURTC to comply with those requirements.

Item 11. Is it derived from or make use of other copyrighted works; or may it otherwise be subject to the rights of others in pre-existing material (s) or inventions? Are any portions of the work subject to licenses from third parties?
